



In 1998, VSA Lithuania "Guboja" founded the Lithuanian National Colour Music Orchestra, in which 60 persons (of which 45 are disabled, mainly young people from various regions of Lithuania; the core is made of the youngsters from 6 educational establishments of the disabled) are performing according to the method of colour-based education (such method is based on the use of colours instead of standard music notes, in such a way making easier the disabled to learn playing). The orchestra annually holds 10-25 cultural and educational events (concerts, creative workshops, music camps, festivals, etc.) all over Lithuania, actively performs abroad (the Netherlands, Belgium, Germany, Poland, Hungary, Latvia, etc.).

At the moment VSA Lithuania "Guboja" is making an EU project about mentally disabled, socially risky and socially excluded people integration into work market. The project is named "people with mental disabilities integration into work market trough participation in national Colour Music Orchestra".

- Objectives: One of our aims at the moment is to prepare technical personnel and additional helpers for National Colour Music Orchestra work activity. Most of these workers would be people with mental disabilities.
- At the moment we are facing problem of finding lecturers in Lithuania who could perform qualification improvement courses for specialists working in this project. The aim of these courses is to provide knowledge of what methods should be used to integrate people with mental disorder more effectively.
- Activities: During project implementation process in 2012
 we would like to organise qualification improvement
 courses for specialists working with this project. These
 courses could be held in one of EU countries or we could
 invite a lecturer from EU to come to Lithuania.
- Our expectations are that after these training courses specialists could achieve much better results while helping people with mental disabilities and more people would be integrated into work market. These outcomes would confirm the success of the project.
- International collaboration and qualification improvement courses could be held in exchange of best practices, field visits and similar forms of international cooperation.
